





BACKGROUND:

Government Code § 87306.5 requires local government agencies to review their adopted Conflict of Interest Code every two years to determine whether the Code is accurate or whether amendment is necessary. The District's last update filing was in early 2022, at which time there were several changes. The last biennial review was in 2020.

DISCUSSION:

District Counsel Robert James and Board Secretary have reviewed the District's Code for compliance with Government Code §87302.

The following recommendations to the Code are proposed as language that is amended, added or removed:

1. The reporting categories for the following positions were revised to reflect more closely the job descriptions as they are now constituted and/or due to changes in the job titles: Fleet Maintenance Supervisor and Executive Assistant/Board Clerk.

The entirety of the recommendations is noted in the Highlight/Strikeout version, in Attachment "A."

In August 2021 the Board awarded *Matrix Consulting Group* a contract to conduct an organizational Strategic Plan. The intent on the Plan was to identify strategic direction for the next 3-5 years with 20-year strategic considerations.

DISCUSSION:


For the last eleven months, an organizational analysis was conducted by *Matrix Consulting Group* which included a review of existing agency procedures, policies, reports, and plans. The analysis involved interviewing members of the organization including the Board of Directors. The community also participated through a community forum and a comprehensive widely distributed agency community survey. From the many months of analysis, Matrix created an organizational Strategic Plan for the NCFPD. The Plan includes identified "strategic goals," which are categorized into three categories: short, intermediate and long-range.

Fiscal Analysis:

The strategic plan was developed in compliance with the contracted scope of work that was awarded in the \$72,000 contract which included all fees and expenses.

Summary:

The Draft Plan has been reviewed by the agency Strategic Planning Working Group including Executive Staff. The team is pleased with the Plan and feels it accurately identifies goals that have been identified as strategic direction priorities by our stakeholders. When approved, this Plan will provide guidance and direction for District decision making and governance for years to come.

DISCUSSION:

FISCAL ANALYSIS:


Staff would execute a Special Services Contract with Hoch Consulting for under \$30,000.





RECOMMENDATION:

It is recommended that the Board of Directors adopt the attached Resolution 2022-18, which updates the Pay Schedule for application of the salary formula.

BACKGROUND:

The California Code of Regulations, Title 2, Section 570.5 requires a governing body's Board of Directors to adopt a pay schedule which delineates the range of pay for all positions and make them available to the public, without reference to another document.

DISCUSSION:

The current pay schedule does not reflect pay raises reflected in the FY22/23 formula. Accordingly, it is necessary to adopt Resolution 2022-18 and post the referenced pay schedule (Exhibit 'A') on the Department's website. As future adjustments to rates of pay will require similar action by the Board of Directors, future resolutions will occur in concert with approval of bargaining unit or individual employee contracts.

FISCAL ANALYSIS:

The fiscal impact applying a 4.67% pay increase will be \$492,362 to the District. Pay raises will go into effect September 1, 2022 and will be reflected in the FY22/23 final budget.

SUMMARY:

Staff recommends that the Board adopt Resolution 2022-18 and Exhibit A as presented.

BACKGROUND:

Each year the Board of Directors are required to adopt a Final Budget by October 1st.

DISCUSSION:

The Budget captures the revenue and expenses for each Fiscal Year and references the past year to allow the Board of Directors to analyze how the District is performing. The Board of Directors has a vested interest in analyzing the overall District financial health including the designated reserve funds. Budgetary numbers provided are estimates since estimated charges and other significant budgetary information will not be available until early June. The concept is to have property tax, ambulance and prevention fees to fund personnel, operations, and maintenance (O&M) and designate a percentage to reserves. The intent is for the District to become "cash" only for capital equipment expenditures saving on interest. The remaining revenue accounts would be the source of these monies towards capital expenditures. The goal is to fully fund the future equipment replacement plan.

FISCAL ANALYSIS:

Staff will be prepared to discuss anticipated revenue and expenses.

SUMMARY:

Staff will take all recommendations from the Board of Directors to provide a Budget to meet all the needs of the District.

New Website Accessibility Guidance a Welcomed Tool for Businesses and Agencies

The U.S. Justice Department (DOJ) has issued web accessibility guidance under the Americans with Disabilities Act (ADA). While many courts have historically held that business and public agency websites are required to be accessible under respective provisions of the ADA, there are no enforceable standards on website accessibility, as there are under Section 508 for federal government websites. Because the DOJ has noted that enforcement of website accessibility is a priority, businesses and public agencies should immediately become familiar with this new guidance and ensure that all components of their websites are in compliance.

The new guidance explains how state and local governments (entities covered by ADA Title II) and businesses open to the public (entities covered by ADA Title III) can make sure their websites are accessible to people with disabilities in compliance with ADA. Specifically, it provides information about:

- Barriers that inaccessible websites create for people with disabilities
- When the ADA requires web content to be accessible
- Helpful practices to make web content accessible
- Additional details and resources

As the DOJ has stated, the guidance is intended to provide plain language and user-friendly explanations to ensure it is comprehensible for general readership – not just those with a legal or technical background. The guidance explains that businesses and governments can choose how to make their programs and services offered on their websites accessible, since there is no specific standard. However, it also confirms that the Web Content Accessibility Guidelines (WCAG) and Section 508 standards should still be considered helpful guidance, and entities should continue to reference these standards for the more technical and detailed guidance on website accessibility.

Examples of Website Accessibility Barriers

• **Poor color contrast**. People with limited vision or color blindness cannot read text if there is not enough contrast between the text and background (for example, light gray text on a light-colored background).

- Use of color alone to give information. People who are color-blind may not have
 access to information when that information is conveyed using only color cues
 because they cannot distinguish certain colors from others. Also, screen readers do
 not tell the user the color of text on a screen, so a person who is blind would not be
 able to know that color is meant to convey certain information (for example, using
 red text alone to show which fields are required on a form).
- Lack of text alternatives ("alt text") on images. People who are blind will not be able to understand the content and purpose of images, such as pictures, illustrations, and charts, when no text alternative is provided. Text alternatives convey the purpose of an image, including pictures, illustrations, charts, etc.
- No captions on videos. People with hearing disabilities may not be able to understand information communicated in a video if the video does not have captions.

Motorcyclist killed in Fallbrook crash

Crash occurred about 3:40 p.m. on East Mission Road at Via Zancas, about two miles west of Interstate 15

FALLBROOK - A 63-year-old Escondido man died Tuesday after crashing his motorcycle and then being hit by a car in Fallbrook, authorities said.

The incident happened about 3:40 p.m. on East Mission Road at Via Zancas, according to California Highway Patrol spokesperson Officer Hunter Gerber.

According to a preliminary investigation, the rider was heading east on a Honda CTX when he lost control around a right-hand curve on the two-lane highway, Gerber said. He went down in the oncoming traffic lane and was thrown from his motorcycle as he

struck the pavement. He was then hit by a Mercedes-Benz C250 coming from the opposite direction.

Firefighters began performing CPR on the severely injured rider before paramedics took him to Palomar Medical Center in Escondido, North County Fire Protection District spokesperson Capt. John Choi said.

The rider, whose name was not released, died at the hospital, according to Gerber. Neither alcohol nor drug impairment were suspected factors in the crash.

Proponents Submit 1.4 Million Signatures to Qualify Initiative Limiting Ability of Voters and State and Local Governments

Proponents of Initiative #21-0042A1 submitted 1,429,529 signatures by the August 2 deadline to qualify the constitutional amendment for voter consideration. Should county elections officials confirm the validity of at least 997,139 signatures, the initiative to limit the ability of voters and state and local governments to raise revenues for government services will be placed on the November 2024 statewide ballot. CSDA is calling on all special districts to join the more than 150 local governments that have already passed resolutions in opposition to the costly measure.

The purported "Taxpayer Protection and Government Accountability Act," sponsored by the <u>California Business Roundtable</u> ("CBRT"), is the most consequential proposal to limit the ability of the state and local governments to enact, modify, or expand taxes, assessments, fees, and property-related charges since the passage of Proposition 218 (1996) and Proposition 26 (2010). If enacted, public agencies would face a drastic rise in litigation that could severely restrict their ability to meet essential services and infrastructure needs.

County elections officials are in the process of conducting a random sample verification of the 1.4 million signatures submitted by proponents. They have 38 working days from the submission of signatures to confirm whether the random sample process yields a sufficient number of valid signatures. If the random sample verifies 110 percent of required signatures, then the initiative qualifies automatically. If it yields less than 95 percent of necessary valid signatures, then it fails. If it yields less than 110 percent, but greater than 95 percent, then elections officials receive another 30 working days to conduct a full check of all signatures. Interested parties can track the results of the ongoing count on the website of the California Secretary of State.

CSDA has joined a coalition of local government leaders in adopting an "Oppose" position on Initiative 21-0042A1 and encourages all special districts, partners, and community leaders to join the coalition.

COVID-19 Treatment, Novavax Vaccine Available in San Diego

If you get COVID-19, do you know there is **treatment available that can keep** you from getting severely sick?

There is. But you must act fast.

Antiviral pills and monoclonal antibodies should be given within days after the onset of symptoms to be effective. So, you should get tested for COVID-19 as soon as you start developing symptoms. If you are 12 or older and test positive and are at high risk of progressing to severe disease, contact your doctor immediately so that you can get treatment.

People with certain medical conditions are at high risk of developing severe COVID-19, including those with:

- Age over 50 years
- Asthma
- Cancer
- Chronic heart, lung or liver disease
- Diabetes
- HIV
- Mental health and substance use disorders
- Overweight or obese
- Pregnancy
- Smoking, current and former
- Unvaccinated or not up to date on COVID-19 vaccinations
- Other factors, like race and ethnicity

If you do not have a healthcare provider, you can call 2-1-1 to find one. You can also call a **Monoclonal Antibody Regional Center** at (619) 685-2500 to access monoclonal antibody treatment at no cost, regardless of health insurance or immigration status.

"Monoclonal antibodies and antiviral pills work great to keep people from developing severe COVID-19," said Wilma

you're at higher risk of developing severe illness, you should seek treatment immediately."

Treatment centers and medical offices in the region may offer oral antiviral pills, which are taken by mouth, and/or monoclonal antibodies, which are delivered as an intravenous infusion. Your healthcare provider will determine what treatment option is best for you based on your symptoms, age and potential underlying conditions.

Novavax Vaccine is Available

Novavax, a more traditional vaccine against COVID-19, is now available in San Diego County.

You can get Novavax at local healthcare providers, retail pharmacies, and community clinics, as well as County public health centers and community vaccination events. You can make an appointment or find a walk-in clinic here.

Novavax has been authorized as a two-dose primary series, given three to eight weeks apart, to people ages 18 and older. Clinical trials showed that the vaccine series is 90% effective at preventing mild, moderate and severe COVID-19.

Everyone 6 months and older can get **COVID-19 vaccines at no cost**. For those who received an mRNA vaccine, boosters are available for people 5 years and older. Parental consent is required for all eligible minors to be vaccinated.

Vaccination Progress:

- Received at least one shot: Nearly 3.01 million or 90% of San Diegans age six months and older are at least partially vaccinated.
- Fully vaccinated: Nearly 2.66 million or 79.5%.
- Boosters administered: 1,432,313 or 58.7% of 2,439,821 eligible San Diegans.

 More vaccination information can be found at coronavirussd.com/vaccine.

Deaths:

- 13 additional deaths were reported since the last report on Aug. 4, 2022. The region's total is 5,437.
- Of the 13 additional deaths, four were women and nine were men. They died between Jan. 21 and Aug. 7, 2022; six deaths occurred in the past two weeks.
- Five of the people who died were 80 years or older, three were in their 70s, one was in their 50s and four were in their 40s.
- Six were fully vaccinated and seven were not.
- 12 had underlying medical conditions and one did not.

Cases, Case Rates and Testing:

- 3,097 COVID-19 cases were reported to the County in the past three days (Aug. 8 to Aug. 10, 2022). The region's total is now 898,520.
- 7,045 cases were reported in the past week (Aug. 4 through Aug. 10) compared to 9,495 infections identified the previous week (July 28 through Aug. 3).
- San Diego County's case rate per 100,000 residents 12 years of age and older is 52.03 for people fully vaccinated and boosted, 34.81 for fully vaccinated people and 103.28 for not fully vaccinated San Diegans.
- 6,748 tests were reported to the County on Aug. 6, and the percentage of new positive cases was 12.1% (Data through Aug. 6).
- The 14-day rolling percentage of positive cases, among tests reported through Aug. 6, is 12.9%.

NCFPD Knocks down vehicle/vegetation fire





"(This weekend) was emotional," she says. "I don't want him on that wall, but the fact that he will be up there forever is an incredible honor."


Valenta started the Andy Valenta Melanoma Foundation in her late husband's honor. She uses it to provide free skin cancer screenings to fire departments across the state.

DE LUZ - A brush fire erupted today at the end of a dirt road in the unincorporated community of De Luz, scorching about an acre before Cal

Fire aircraft boxed it in during a series of drops.

The non-injury blaze was reported at 4:55 p.m. in the area of Patton and Gavilan Mountain roads, just west of Temecula, according to the Riverside

County Fire Department.

Multiple engine crews were sent to the location and encountered flames moving slowly through heavy vegetation, well clear of homes in the sparsely populated area, the department reported.

Three Cal Fire air tankers and two water-dropping helicopters were called in to make runs on the fire, slowing its advance, enabling crews to

begin establishing containment lines, according to officials at the scene.

Using its rope rescue equipment, the crews were able to help the old horse get back on its hooves. Seems the old horse was suffering from heat exhaustion and the river gave it a brief respite.

Small plane crash in Fallbrook leaves passenger dead, pilot injured

FALLBROOK — One person died and another was injured when a single-engine plane crashed at a plant nursery in Fallbrook early Saturday afternoon.

The crash happened on Olive Hill Road just west of South Mission Road, according to Capt. John Choi of the North County Fire Protection District. The district reported the crash in a Tweet on its official Twitter account at 1:52 p.m.

Choi said the passenger died in the crash. The pilot suffered serious injuries and was taken to Palomar Medical Center. No other information on either person was immediately available.

The address of the crash is listed as a plant nursery. No one answered when the Union-Tribune called the business.

The location is less than a mile south from the county-owned Fallbrook Airpark. Choi had no information on where the flight originated or where it was going.

Late Saturday afternoon, the Federal Aviation Administration confirmed that that the plane was a single-engine T-28, manufactured by North American Aviation, that crashed while attempting to land at the airpark's runway 28 around 1:30 p.m. Two people were on board the aircraft, the agency said.

The FAA and the National Transportation Safety Board will investigate the crash, and any updates are expected to be provided by the NTSB.

The plane appeared to be a T-28 Trojan, a military trainer aircraft used by the Air Force and Navy beginning in the 1950s. Based on a serial number on the plane visible in a photo of the crash, it is owned by a jet air charter company in Chino.

The website FlightAware showed that a T-28 Trojan with the same serial number left Chino Airport at 12:34 p.m. and landed in Fallbrook Airpark at 12:52 pm. That was an hour before the first Tweet on the crash from North County Fire Protection was posted.

In a tweet, the San Diego County Sheriff's Department asked anyone who may have photos or videos of the crash send an email to witness@ntsb.gov.

Fallbrook Airpark covers about 290 acres and is located a couple miles south of downtown Fallbrook. It has a single 2,190-foot-long runway.

The most recent incident there appears to have occurred on Nov. 11, 2020, when a pilot in a single-engine Bellanca Citabria aircraft had to make an emergency landing because of engine troubles. The plane landed but ended up skidding off the end of the runway about 50 feet. The pilot suffered minor injuries.


